CALL FOR APPLICATIONS FOR ADMISSION TO THE MASTER'S AND DOCTORAL PROGRAMS Graduate Program in Chemistry/Unicamp - 1st Semester Of 2026

1. GENERAL INFORMATION

Applications for admission to the **Master's and Doctoral Programs** of the Graduate Program in Chemistry at the Institute of Chemistry of UNICAMP (**IQ-UNICAMP**) will be open from **November 18 to December 12, 2025, with no extensions**.

The selection process will be carried out **exclusively** based on the **normalized score** obtained by the candidate in the **Unified Chemistry Exam (EUQ)**, coordinated by the Brazilian Chemical Society (SBQ).

The candidate may use:

- The score obtained in the 2025/2 edition of the EUQ, scheduled for 11/16/2025;
 OR
- The score obtained in the 2025/1 edition of the EUQ, held on 05/18/2025.

When submitting the official certificate, the candidate must choose **only one** of the scores.

The **number of openings** will be defined by the Graduate Studies Committee (CPG-IQ) in an extraordinary meeting , based on the scores obtained by the applicants and the definition of the cutoff score.

The Graduate Program in Chemistry adopts **affirmative action policies**, reserving **25%** of the total available openings for ethnic-racial quota modalities.

The CPG-IQ/UNICAMP is not responsible for applications that are not finalized due to technical problems, network congestion, or any failures outside the institution's control.

2. CANDIDATE'S RESPONSIBILITIES

The candidate must:

- 1. **Register for the EUQ** directly on the SBQ website (https://euq.sbq.org.br/), observing the deadlines, requirements, and procedures established by the examination organization;
- 2. **Take the EUQ** in the chosen edition (11/16/2025) or have participated in the immediately previous edition (05/18/2025), provided they opt to use this score in the selection process and submit the respective official certificate;
- 3. Obtain the official certificate with the score, issued by the SBQ;
- 4. Register on the DAC-UNICAMP system between 11/18/2025 and 12/12/2025;
- 5. Send the official certificate with the EUQ score to the email ingresso.cpgiq@unicamp.br by 12/12/2025.

Important: The omission of any of these steps—EUQ registration, taking the exam, DAC-UNICAMP registration, and sending the certificate—renders the candidate's approval impossible. All information regarding EUQ registration, dates, payment, content, format, and results is the **sole responsibility of the candidate**.

3. REGISTRATION AT UNICAMP (DAC) AND SUBMISSION OF THE EUQ CERTIFICATE

Registration must be done **exclusively online**, by completely filling out the form available on the DAC-UNICAMP website <u>at this LINK.</u>

At the time of registration, all requested information must be filled out correctly.

The EUQ certificate is **not** submitted through the DAC system, but directly to **ingresso.cpgiq@unicamp.br**, by the final registration date (12/12/2025).

Exclusively for Master's admission: The Graduate Program in Chemistry will adhere to the Graduate Studies Improvement Program (PAPG).

In this case, master's students, exclusively CAPES scholarship recipients, who complete the formative track proposed by the Program and obtain approval in the Qualification Exam within 12 months will be eligible to apply for a direct transfer to the doctoral program with scholarship complementarity from FAPESP. This complementarity will be granted by FAPESP to one (1) scholarship recipient at the beginning of 2027. The formative track (i.e., the set of credits to be completed and other mandatory activities) and the criteria for classifying candidates for the scholarship complementarity will be informed by the CPG-IQ at the beginning of the academic semester. Candidates interested in participating in the PAPG must fill out the form available at this LINK. Filling out the form does not guarantee the availability of a master's scholarship nor its complementarity if there is a transfer to the direct doctoral program, and it does not waive the submission of the EUQ certificate and the completion of the DAC-UNICAMP form.

4. CLASSIFICATION CRITERIA

The classification of candidates will be made **exclusively** based on the **EUQ score normalized** with respect to the average score of the edition chosen by the candidate.

The **cutoff score** will be defined by the CPG-IQ in an special meeting, considering the general performance of the applicants, the historical admission average, and the availability of scholarships.

5. SCHOLARSHIP CLASSIFICATION

The classification for eventual **institutional scholarships** will strictly follow the **descending order of the scores** obtained in the EUQ.

Only candidates who **enroll** in the course for which they were approved will compete for scholarships.

6. TIE-BREAKER CRITERIA

In case of a tie in the EUQ score, the following criteria will be applied, in this order:

- 1. Candidate aged **60 years or older**;
- 2. Shorter time elapsed since obtaining the undergraduate or master's degree;
- 3. Candidate who **self-identify** as Black, Brown, or Indigenous;
- 4. Older candidate;
- 5. **Random draw** held in the presence of the candidates

7. EUQ WAIVER AND SCHOLARSHIP ELIGIBILITY

Some candidates may be **waived from taking the EUQ**, according to the Norms for Admission to the Master's and Doctoral Programs of IQ-UNICAMP available on the Program's website.

All waived candidates must complete the registration on the **DAC-UNICAMP system**.

Important: The granting of a waiver from taking the EUQ automatically implies the candidate's **ineligibility to compete for institutional scholarships**.

Cases for a waiver are:

- a) Candidates who have a **scholarship** granted or in the process of evaluation for the intended course, financed by a public or private entity, with a minimum duration of **12 months (Master's)** or **24 months (Doctoral)**;
- b) Exclusive for Master's admission: Candidates who have been Scientific Initiation scholarship recipients for a minimum of 18 months, under the supervision of the same professor who will advise them, and who have been approved with a concept of A or B as a special student in a mandatory discipline in the area of concentration;
 - **Proof:** In all the cases above, the **waiver request** must be forwarded by the advisor with the respective proof to **ingresso.cpgiq@unicamp.br**;
- c) Candidates who have completed their **Master's degree in the Graduate Program in Chemistry at UNICAMP** will be waived from the EUQ for admission to the Doctoral program.

Attention: Candidates who meet the waiver criteria but wish to **compete for institutional scholarships** must participate in all the steps described in item 2 of this call.

8. RESULTS

All **individual communication** will be made **exclusively by email**, using the address provided during the DAC-UNICAMP registration.

General information will be published on the CPG-IQ website and the EUQ website.

9. FINAL PROVISIONS

Cases not covered in this cal will be resolved by the Graduate Studies Committee of the Institute of Chemistry of UNICAMP.
